CASE STUDY: KI SAWYER WASTE WATER TREATMENT FACILITY

When Marquette County first bid out the wastewater treatment facility improvements for the KI Sawyer community, the project came in substantially over budget. This put their entire project at risk because of the time restrictions on their USDA loan. Marquette County needed to bring the project within budget or lose the money. Using value engineering techniques, GCI worked with Marquette County, the project engineer, and subcontractors to bring the project back within budget, and within the completion time frame the County needed to meet USDA requirements. The project funding was approved, and the project provided the County with a wastewater treatment facility that operates at higher functional levels than have been seen in decades.



CASE STUDY: ALGER COUNTY JAIL

With a tight schedule and even tighter budget, Alger County turned to Gundlach Champion for the design/build renovation and expansion project at their County Jail facility. GCl and its design team worked with Alger County on an accelerated design schedule to complete the design and begin construction as soon as possible. Needing to remain operational, GCl worked with Alger County on the phasing of the work to ensure they had the maximum amount of space available throughout the renovation portion of the project. The work included new detention equipment, controls system, and an increase of almost double for occupants.



CASE STUDY: MARQUETTE MUNICIPAL SERVICE CENTER

Due to the impending sale of the property containing its old municipal service center, the City of Marquette, bound a tight budget and schedule, needed to construct a new facility. To meet the budget and fast track schedule, GCI worked with the City of Marquette and its design partner develop a floor plan for the new 100,500 square foot two-story office, vehicle maintenance area, and vehicle storage area. With the plan GCI developed, containing all the elements the City needed, and a few of their



items from its wish list, they were able to work within their project constraints. Because the building was designed with precast concrete walls, GCI was able to expedite the production and installation of the panels to ensure the project stayed on schedule.
